

## Parental Permission, Waiver, and Release 2017 Season

1. Player, and his custodial parent(s) and/or legal guardian(s) (together referred to as "undersigned"), hereby consent to player's participation with Muskego Rugby Club (MRC). The undersigned understands and agrees that participation includes, but is not limited to, practice sessions, games, meetings, functions, parties, fund-raising, and the like, and transportation to and from these activities. The undersigned further understands that some drivers may be underinsured or uninsured and the undersigned agrees to supplement their insurance to provide for sufficient underinsured or uninsured coverage to compensate for any losses resulting from injury or death in connection with a transportation mishap and the undersigned otherwise waives claim against any driver beyond his or her insurance coverage as well as against MRC, coaches and against the Wisconsin Rugby Football Union (WRFU) officials and administrators.
2. The undersigned understands and agrees the MRC is not sponsored by any High school, School District or the Milwaukee Archdiocese and as such, these institutions and their administrators and officials are not responsible or liable for injury, sickness, disability, paralysis or death that may result from player's participation with the MRC and all claims against said entities and individuals are waived.
3. The undersigned understands that there are no salaried coaches or administrators assisting the MRC. All those who help are volunteers.
4. The undersigned understands that rugby is an exciting, rough, physical contact sport and that as with all sports, that possibility of injury, be it serious or minor, always exists. The undersigned hereby accepts the risks that accompany participation. The undersigned agrees that they will not hold the officials, administrators, coaching staff, MRC and/or WRFU responsible for injury, sickness, disability, paralysis or death that may result from participation with the MRC and all claims arising from such participation are waived.
5. Release and Waiver of liability: in consideration of player's rights to participate, the undersigned hereby releases discharges and covenants to sue the coaches, officials and/or administrators of the MRC, the Wisconsin Youth Rugby Association, the Waukesha High School Rugby Football Union, and the sponsors and workers. The undersigned agrees that this release is binding and effective as to themselves as well as to their personal representatives, assigns, heirs, and next of kin, and that it applies to any and all loss or damage claimed on account of injury, disability or death, whether caused by negligence of the above referred to entities, organizations or individuals or otherwise.
6. The undersigned understands by signing this release that they are giving up substantial rights they would otherwise have to recover damages for losses and that they are doing so voluntarily and without inducement, threat or duress. The undersigned agrees that they have had the opportunity to seek legal advice before signing this release and have either done so or voluntarily elected not to and waives this opportunity.

7. The undersigned understands that there is not a medical physician or trainer at the MRC's practice sessions, but will have a medical professional provided at all Home games.
8. The undersigned understands and agrees to be solely responsible for the following:
- a. To see that player has a physical to determine that he is able and fit to play rugby.
  - b. To see that player has appropriate medical insurance.
  - c. To see that player wears a mouthpiece during all practices and games.
  - d. To see that player avoids the use of alcohol, tobacco, and/or controlled substances without proper prescriptions.
  - e. To see that player abides all MRC rules.
  - f. To see that player keeps his life clean and in accordance with the laws and regulations of WRFU.
9. The undersigned agrees to accept all responsibility, including medical and financial, for participation and to pay the MRC dues. The undersigned understands that each player must play in a regulation uniform which consists of jersey, socks, shorts, and approved shoes; that player is required to purchase his shorts, socks, and shoes, but may use a MRC jersey provided by the MRC, which is to be returned at season end. I/we have read, understand and agree to the information and waiver and release of liability as set forth above.
